

L.A.S.I. s.r.l. with registered office in Meolo (VE), Via delle Industrie II 43, postcode 30020, in its capacity as data controller (hereinafter referred to as "Controller"), issues this privacy notice to the data subject, in compliance with European and Italian regulations on data protection.

## Purpose and legal basis of the processing

The Controller processes personal data for various purposes:

- 1. adopting pre-contractual measures requested by the Data Subject, such as, for example, the sending of information on products or services (including the sending of the brochure, catalogue and/or other company information material) or a quotation, as well as fulfilling contractual and regulatory obligations connected with the business relationship and pursuing the legitimate interest in the correct management of the relationship itself, verification of the data subject's solvency and the management of any disputes: the legal basis for the processing is the need to pursue the above-mentioned purposes
- 2. using the Data Subject's contact details (e-mail address, fixed and mobile telephone number, postal address) to send sales messages containing information on products or services, as well as promotions or invitations to events in which the Controller will participate: express consent is required for this purpose.

## Period of data storage

The Controller intends to process the data according to the following time criteria:

- ▶ if information is requested, the data will be processed for the time necessary to reply; if a quotation is requested, on the other hand, the data will be processed for the time necessary to pursue the purposes for which it was collected, without prejudice to further storage for the time necessary to settle (however reached) any disputes that may arise
- if the Data Subject becomes a customer of the Controller, the data shall be processed for the entire duration of the business relationship and, subsequently, for the fulfilment of any obligations connected with or arising from the establishment of the same, for the period prescribed by law and in accordance with the limitation period for rights arising from the business relationship, without prejudice to further storage for the time necessary to settle (however reached) any disputes that may arise
- for the purpose referred to in point 2), the data will be processed for twenty-four months from the last notification, regardless of the channel used: the data subject may withdraw consent or object to the processing at any time.

### Nature of data provision and consequences of refusal

The provision of data for the Purposes referred to in point 1) is necessary and therefore any refusal to provide such data wholly or partially may make it impossible for the Controller to pursue the above purposes. The provision of information for further purposes is optional: without it, the Controller will not be able to carry out the corresponding activities but will still be entitled to pursue the purposes referred to in point 1).

### **Recipient categories**

The Controller will not disseminate the data, but intends to disclose it to internal figures authorised to process it due to their respective duties, as well as to sales agents, professionals, third-party suppliers involved in the execution of orders received by L.A.S.I. s.r.l., credit institutes, sales information and consulting companies, business associations and/or organisations, professionals or service companies and public and private bodies, also following inspections and audits. These recipients, should they process data on behalf of the Controller, will be appointed as data controllers by means of a contract or other legal deed.

### Transfer of data to a third country and/or international organisation

As a rule, your personal data will not be transferred to non-European third countries, unless this is necessary for the performance, in the interest of the customer, of contractual obligations in those countries. In this case the personal data being processed may be communicated to local contacts of L.A.S.I. s.r.l. for the exclusive purpose of punctually carrying out the order received from the Customer. The Data Controller reserves the possibility of using cloud services: in this case, the providers of such services will be selected from among those who provide adequate guarantees, as provided for in section 46 GDPR.

### Data subject rights

Data subjects have the right to ask the Controller to access their personal data and rectify it if it is inaccurate; erase it or restrict its processing if the conditions are met; object to its processing for legitimate interests pursued by the Controller; and obtain the portability of the data personally provided, only if it is subject to automated processing based on consent or contract. Data subjects shall also be entitled to withdraw consent for the processing purposes which require this, without prejudice to the lawfulness of the processing carried out until the time of withdrawal.
